Activity Report by OTD Chile Period 2020

Due to the global health crisis caused by COVID-19, our activities were affected in terms of planning and executing face-to-face activities, most of which were suspended or rescheduled as online activities. The government's ban on activities that involve bringing people together affected the community approach to our work, so we had to focus on bringing this approach to virtual spaces. A large part of our team work was teleworking.

Below we give details of the activities done in relation with the previously established objectives and emergency responses to the COVID-19 crisis.

A. Political Impact

A.1 Follow up on the implementation of the Gender Identity Law

According to government figures, 2,291 name and sex changes had been processed through the Gender Identity Law between November 2019 and December 2020. 84 of these cases were people under 18 years old.

In March 2020 when the pandemic started, trans people could not attend the hearing in the Registro Civil (Civil Registry) that establishes the law allowing name and sex changes. This delayed the changes of several people and we received a lot of pressure to do something about it. After speaking with several authorities at the Registro Civil, they finally changed the method and allowed a part of the process to be done through a phone call, which helped to expedite the process. However, we have received several complaints from trans people who have not been able to access the process and we have advised them directly by contacting the Registro Civil to seek solutions.

We held meetings with authorities of the Servicio Nacional Electoral (National Electoral Service) to expedite the updating of the electoral rolls in the case of transgender people, so that they could vote with their new identity in the national plebiscite for a new Constitution for Chile.

Our goal was to encourage the incorporation of transgender population questions in an appropriate way that considers the new gender identity law.

Challenges

The main challenges were how to transition to telework. We had to adapt quickly to this new way of working.

During the first half of 2020, we had to postpone our planning to focus on actions to face the COVID-19 crisis that was starting, as well as finding ways to deliver food to transgender people who need it most.

Unfortunately, the work with the Ministry of Health on issues related to the gender identity law has come to a standstill as the Ministry is only concerned with COVID-19 issues and has put sexual and reproductive health issues aside. Between March and May, there was a strong health crisis related to these issues as some hospitals were not even treating people with HIV/AIDS.

We also lost financial resources as one of our top funders, who had promised us support for 2020, didn't send us the money. This forced us to cut resources from other costs. Luckily, we were able to compensate with savings in physical space rentals since most of the work was online.

Learning

Although we had to postpone our planning, this gave us time to make a better guided process and create a more effective planning methodology with the help of the Department of Sociology of Diego Portales University.

We also showed that access to economic resources for the sustainability of our work was being affected by the socioeconomic crisis generated by COVID-19, therefore in our 2021 planning, we incorporated new strategies to search for resources.

Working online helped us discover and incorporate new digital tools that were previously unknown to us and that have now made our work easier, such as online applications for teamwork and project monitoring.

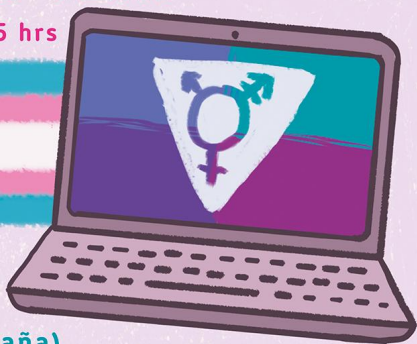
